All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in School District 7-H-1, now within the corporate limits of the City of Greenville, being known and designated as Lot No. 15, of Block D, of a subdivision known as Fair Heights, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "F" at Page 257, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Bleckley Avenue at the corner of Lot No. 14, of Block D, which point is 50 feet North of the interesection of Decatur Street, and running thence along the line of Lot No. 14, N. 58-40 W. 150 feet to an iron pin at the rear corner of said lot: Thence along the line of Lot No. 12, N. 31-20 E. 50 feet to an iron pin at the rear corner of Lot No. 16: thence along the line of Lot No. 16, S. 58-40 E. 150 feet to an iron pin at the corner of said lot on the Northwest side of Bleckley Avenue: thence along the line of said Bleckley Avenue, S. 31-20 W. 50 feet to the beginning corner.
