This deed is made subject to restrictions applicable to Sherwood Forest and recorded in the R. M. C. Office for Greenville County, S. C., in deed Book 412, page 149, and further subject to utility easements of record. TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

And ~~me~~ the grantor(x) do cs hereby bind himself his heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said Grantee(x) hereinabove named, and his heirs and assigns against himself and his heirs and assigns, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

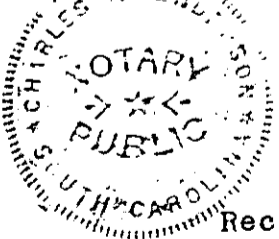
