All that certain parcel or lot of land containing Two (2) Acres, more or less, situated on the west side of the Rutherford Road near Jubilee Church, about four miles north from Taylors, in ChickSprings Township, Greenville County, State of South Carolina, designated as Lot No. 2 of the D. M. Greer Estate, according to survey and plat thereof by H. S.
