There is excepted and excluded from this conveyance so much of the personal property above mentioned as may be located upon the lot above described, and this conveyance is made subject to the rights of way and easements above mentioned insofar as they may affect said let.

This conveyance is made subject to the following restrictions:

(1) That no mercantile establishment, other than those already in existence, shall be erected operated or maintained on the lot above described.

(2) That only one residence shall be erected or maintained on any one lot.(3) That no livestock, except fowl, may be kept, stabled or penned thereon or brought to the premises.
