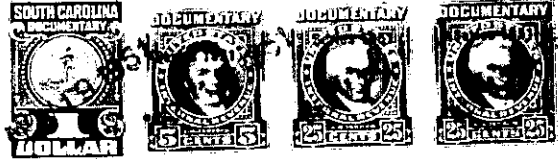

Ayers, as shown on plat made by K. K. Campbell, April 24, 1949, and recorded in the R. M. C. Office for Greenville County in Plat Book W, page 27, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the southwest side of Cardinal Drive, at corner of Lot No. 48; and running thence with line of Lot No. 48, S. 64-02 W. 139.3 feet to iron pin; thence S. 25-58 E. 70 feet to iron pin at corner of Lot No. 50; thence with line of Lot No. 50, N. 64-02 E. 139.3 feet to iron pin on the southwest side of Cardinal Drive; and thence with Cardinal Drive N. 25-58 W. 70 feet to beginning corner, being a portion of the same conveyed to me by Martha J. Edwards by deed dated February 17, 1948, and recorded in Book 336, page 397.

This property is conveyed subject to the following restrictions and conditions Said property to be used for residential purposes only; no residence to cost less than \$5,000.00; no building to be erected nearer than 30 feet from the street on which it faces; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no part of said property to be sold, rented or otherwise disposed of to any person of African descent; property conveyed subject to recorded rights-of-way; no residence to be built on any lot or portion thereof, unless said lot has 50 feet or more street frontage.
