Know All Men by These Presents:

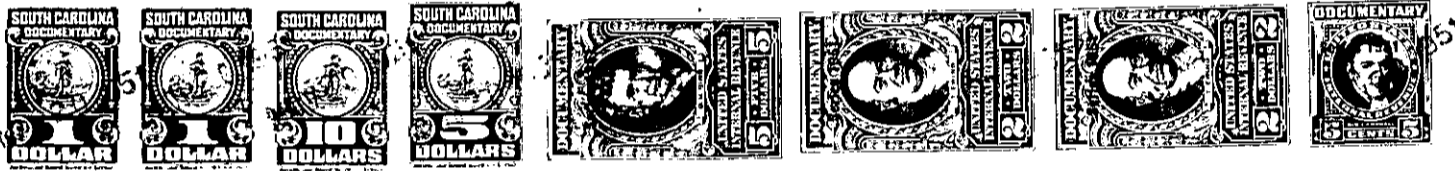

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James E. White, his heirs and assigns, forever:

All that lot of land with the improvements thereon situate on the West side of West Decatur Street near the City of Greenville, in Greenville County, South Carolina, shown as Lot No. 84 on plat of property of J. P. Rosamond, from revised plat of Sans Souci Development Co., made by Dalton & Neves, Engineers, recorded in the R. M. C. office for Greenville County in Plat Book "H", Page 185 and 186, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the West side of West Decatur Street at joint front corner of lots 83 and 84 and running thence with lot 83 N. 83-45 W. 231.5 feet to an iron pin; thence N. 11-05 W. 62.8 feet to an iron pin; thence with the line of lot 85 S. 83-45 E. 250.1 feet to an iron pin on the West side of West Decatur Street; thence along the West side of West Decatur Street S. 6-15 W. 60 feet to the beginning corner.

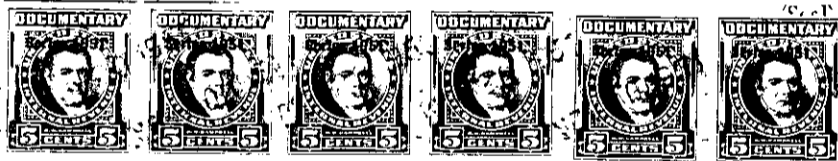
