(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents
do grant, bargain, sell and release unto the said..... W. W. Heller, his heirs and assigns,
forever:

All that certain piece, parcel or lot of land with the buildings
and improvements thereon situate, lying and being on the West side of
Paris View Drive (formerly known as West Fairview Avenue) in that
area recently annexed to the City of Greenville, in Greenville County,
State of South Carolina, being known as Lot 35 of plat of Druid Hills,
made by Dalton & Noves, Engineers, January 1947, recorded in the R.
R. C. Office for Greenville County, S. C., in Plat Book "F", page 113,
and having according to said plat the following metes and bounds,
to-wit:

BEGINNING at an iron pin on the West side of Paris View Drive
at joint front corner of Lots 35 and 36 and running thence with the
line of Lot 36, S. 74-21 E. 208 feet to an iron pin; thence S. 45-22
W. 108.9 feet to an iron pin; thence with the line of Lot 34, N.
58-49 W. 166.8 feet to an iron pin on the East side of Paris View
Drive; thence along the East side of Paris View Drive in a curved
line (the chord being N. 23-25 E. 50 feet) to the beginning corner.
