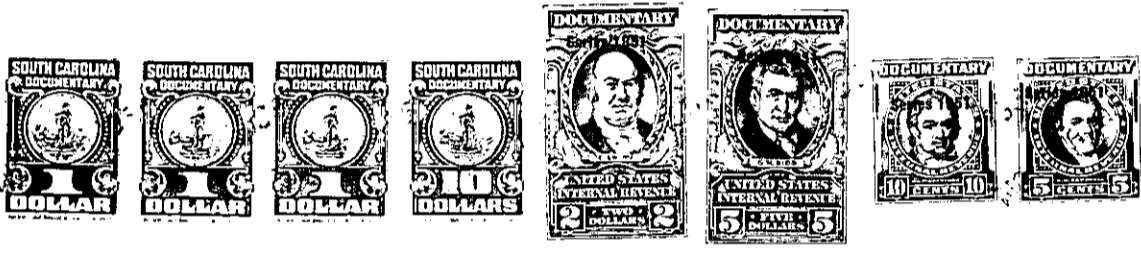

Noon, his heirs and assigns, all that piece, parcel or lot of land situate, lying and being on the Westerly side of Terrell Lane, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 4, Block C, Paris Heights Subdivision, as per plat thereof recorded in the R. L. C. Office for Greenville County, South Carolina, in Plat Book Y, page 65, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Westerly side of Terrell Lane, joint front corner Lots Nos. 4 and 5, which iron pin is 165 feet in a Northerly direction from an iron pin in the Northwest intersection of Terrell Lane and Pisgah Drive and running thence S. 72-30 W. 250.7 feet to an iron pin on the Easterly side of Base Hospital Road; thence along Base Hospital Road N. 14-02 W. 70.1 feet to an iron pin, joint rear corner Lots Nos. 3 and 4; thence N. 72-30 E. 246.5 feet to an iron pin, joint front corner Lots Nos. 3 and 4 on the Westerly side of Terrell Lane; thence along the Westerly side of Terrell Lane S. 17-30 E. 70 feet to an iron pin, the point of beginning.
