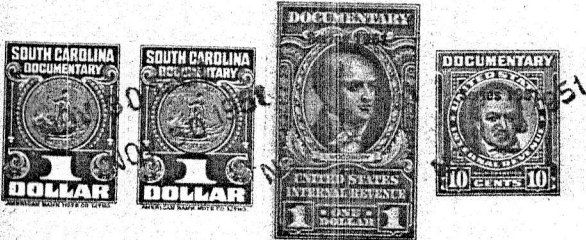

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Henry F. Gillespie, his heirs and assigns, all that piece, parcel or lot of land being known and designated as Lot No. 6, according to a plat of the Estate of Ressie N. Kinion, made by Dalton & Neves, Engineers, dated October, 1948, and according to said plat, having the following metes and bounds, to wit:

BEGINNING at an iron pin at corner of Lot No. 5 on Piney Road and running thence along the line of said Lot No. 5, N. 15-35 W. 169.4 feet to back corner of Lot No. 5; thence S. 64-48 W. 80.5 feet to iron pin on Clairemont Drive; thence with the line of said Clairemont Drive S. 6-35 E. 141.0 feet to iron pin; thence in a curved line at the intersection of Clairemont Drive and Piney Road S. 72-45 E. 30 feet to iron pin; thence along the line of said Piney Road N. 74-25 E. 75 feet to point of beginning.
