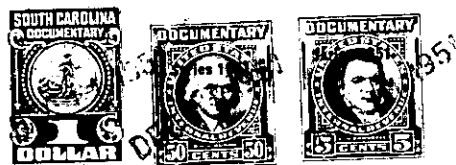

All that certain parcel or lot of land situated on the Northeast side of the road leading from Greer to Oneal by the way of Ballenger's orchard, about one mile Northward from Greer, in Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 13 of the L.W. Jones Estate Property according to survey and plat thereof by H.S. Brockman, Surveyor, dated May 24, 1951, and having the following courses and distances, to wit:

Beginning at a point in the center of said road, corner of Lot No. 14, and running thence along the line of Lot No. 14, N. 54.37 E. 173.8 feet to a stone; thence N. 65.45 E. 125 feet to a stake, corner of Lot No. 12; thence along the line of Lot No. 12, S. 38.48 E. 140 feet to stake, corner of Lot No. 11; thence along the line of Lot No. 11, S. 47.36 W. 391.4 feet to center of road; thence along said road, N. 34.00 W. 201.5 feet to the beginning corner.
