ROFE Know, All Men by These Presents:

That I, H. Sherrill Utley, in consideration of the sum of Thirty Thousand (\$90,000,00) 17575 in the State aforesaid, DOLLARS,

to the grantor(xx) in hand paid at and before the sealing of these presents by the grantee(xx) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said F. G. Moorhead, his heirs and assigns forever,

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, lying on the East side of North Main Street, formerly Mosteller Street, being a part of Lot No. 6 on a plat of the David and Pertina Cannon property made by R. E. Dalton, Eng., August, 1924, and having the following courses and distances:

BEGINNING On a stake on the East side of North Main Street, inside of side-walk, corner of May S. Robison's lot, and runs thence with the line of her lot S. 57.19 E. 242.25 feet to a stake on line of Lot No. 5 of Cannon property; thence S. 31.30 W. 72.15 feet to a stake, corner of F. B. Woodruff's lot; thence with his line, N. 57.19 W. 246.7 feet to a stake at edge of sidewalk on North Main Street; thence with said sidewalk and street, N. 35.03 E. 72.15 feet to the beginning corner.

It is agreed between the parties that the above property shall be used only for residential purposes for a period of fifteen years, commencing August 15, 1945, for the protection of other purchasers of portions of Lot No. 6, and that no residence shall be built within forty (40) feet of North Main Street during said period.

Grantor agrees to pay City of Greer, State and County taxes for 1951.

And the grantor(x) do(es) hereby bind the grantor(x) and the grantor's(x) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(x) Heirs and Assigns against the grantor(3) and the grantor's(3) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
