KNOW ALL MEN BY THESE PRESENTS: THAT, I, JOSEPH M. JANS

my true and lawful attorney to act in, manage, and conduct all my estate and all my affairs, and for that purpose for me and in my name, place, and stead and for my use and benefit, and as my act and deed, to do and receive, or to concur with persons jointly intersted with myself therein in the deing or executing of, all or any of the following acts, deeds, and things, that is to say:

(1) to buy, receive; lease, accept, or otherwise acquire; to sell, convey, mortgage, hypothecate, pledge, cuit claim, or otherwise encumber or dispose of; or to contract or agree for the acquisition, disposal or encurbrance of; any property whatsoever and wheresoever situated, he it real, personal, mixed, or any custody, possession, interest, or right therein or pertaining thereto, upon such terms as my said attorney, shall think proper; (2) to take, hold possess, invest lease, or let, or otherwise merete any or all of my real, personal, or mixed property, or any interest therein or pertaining thereto; to eject, remove, or relieve tenents or other persons from, and recover possession of such property by all lauful means; and to maintair, proteet, preserve, insure, remove, store, transport, repair, rebuild, modify, or improve the same or any part thereof; (3) to make; do, and transact all and every kind of business of whatever kind or nature, including the receipt, recover, collection, propent, compromise; suttlement, and adjust part of 11 accounts, legacies, be west, interesta, dividenda annuities, elais, demands, debts, taxes and obling lions, which can now or here-ft recidue; owing or payable by me or to me; (a) to make, indorse, accept, receive, si m, seal, execute, acknowledge, and deliver deeds, assignments, agreements, certificates, hypothecations, checks, notes, bonds, vouchers, receipte, releases, and such other instruments in writing of whatever kind and natura as may be necessary, convenient, or proper in the promises; (5) to make deposits or investments in, or withdrawals from, any account; holding, or interest which I may now or hereafter have, or be entitled to, in any banking, trust, or investment institution, including postal savings depository offices, credit unions, savings and loan associations, and similar institutions, to exercise any right, option, or privalege pertaining thereto; and to open or establish accounts, holdings or interests of whatever kind or nature, with any such institutions, in my name or in my said attorney's name or in both our names jointly either with or without the right of survivorship; (6) to institute, prosecute, defend compromise, arbitrate, and dispose of legal, equitable, or administrative hearings, actions, suits, attachements, ar ests, distresses or other proceedings or otherwise engage in litigation in connection with the precises; (7) to act as my attorney or proxy in respect to any stocks, sheres, bonds, or other investments, rights, or interests, I may now or hereafter hold; (8) to engage and dismiss agents counsel and employees and to appoint and remove at pleasure any substitute for or agent of my said attorney in respect to all or any of the matters or things herein mentioned, and upon such terms as my attorney shall think fit; (9) to execute vouchers in my behalf for any and all allowences and reinbursements properly payable to me by the U ited States including but not restricted to allowances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law and Air Force regulations, and to receive, indorse, and collect the proceeds of checks payable to the order of the undersigned drawn on the Treasure of the United States; (10) to prepare, execute, and file income and other tax returns, and other governmental reports, declarations, applications, requests and documents; (11) to take possessions, and order the removal and shippent of any of my property from post warehouse, dopot, dock, or other plac of storage or safekeeping, governmental or private and to excute and deliver any release, voucher, receipt, shipping ticket, certificate, or other instrument necessary or convenient for such purpose; (12) to act as my attorney-in
