to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Alvin W. Edwards and Erroll P. Edwards, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being known and designated as Lot No. 24 of a subdivision known as Section "B", of Englewood Estates, as shown by a Plat thereof, dated November, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "BB", at Page 11.

BEGINNING at an iron pin joint corner of Lots No. 24 and 23 and running thence along the line of Lot No. 23, N. 87-30 W. 133.1 feet to iron pin; thence S. 8-49 W. 75.6 feet to iron pin at back corner of Lot No. 25; thence along the line of Lot No. 25, S. 87-30 E. 141.55 feet to iron pin on Cherokee Drive; thence with the line of said Cherokee Drive, N. 2-30 E. 75 feet to point of beginning.
