That I, Walter W. Goldsmith in the State aforesaid, in consideration of the sum of One Thousand Seven Hundred Fifty & 00/100---(\$1,750.00)---DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Nellie Kennemore, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lots No. 75, 76 and 77 of a subdivision known as Section "B", of Englewood Estates, as shown by a Plat thereof, dated November, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "BB", at Page 11.

BEGINNING at an iron pin joint corners of Lots No. 74 and 75 and running thence with the line of said Lot No. 74, S. 87-30 E. 444.6 feet to iron pin; thence S. 3-02 W. 180 feet to iron pin at back corner of Lot No. 78; thence with the line of said Lot No. 78, N. 87-30 W. 442.1 feet to iron pin on Buffalo Drive; thence along the said Buffalo Drive N. 2-30 E. 180 feet to point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than 50 feet to the street.
3. No temporary house is to be erected on said lot.
