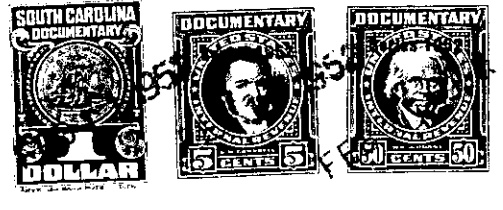

BEGINNING AT AN IRON PIN AT THE RIGHT OF WAY OF HART STREET IN  
THE TOWN OF TRAVELERS REST, AT THE CORNER OF LOT # 6 AND RUNNING N. 54-00 E,  
140 FEET ALONG LINE OF LOT # 6, TO AN IRON PIN; THENCE S. 36-30 E, 70 FEET
