

County, State of South Carolina, on Lenore Avenue between the New Buncombe Boad and
Garnshaw Avenue, in the Sans Souci heights Sub-Division, situate on the New Suncombe road about four miles north of the City of Greenville, said lot having the following lines, courses and distances:-

Beginning at an iron pin on the southern edge of a three (3) foot sidewalk running along Lenore Avenue, said pin being the joint front corner of lots numbered one hundred and thirty-six (136) and one hundred and thirty-seven (137); thence along the southern edge of said sidewalk, N. 58-50 £., ninety and two tenths (90.2) feet, to an iron pin, joint corner of lots two (2) and one hundred and thirty-six (136); thence 3. 39-10 £., one hundred fifty-six and three tenths (156.3) feet, to an iron pin, rear corner of lot one hundred and thirty-six (136); thence 3. 53-32 £., ninety-eight (98) feet, to an iron pin, joint rear corner of lots one hundred thirty-six (136) and one hundred and thirty-seven (137); thence with the eastern line of lot one thirty-seven (137), N. 36-44 W., one hundred and sixty-four and three tenths (164.3) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbered one hundred and thirty-six (136) on plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "YM at page 145, which Plat is hereby referred to and made a part hereof.

The grantor further conveys the right to connect up with the sewer line running across the rear of lot numbered two (2) facing the New Buncombe road.
