KNOW ALL MEN BY THESE PRESENTS. That I, Lenore Perry, of the County of Greenville, in the State aforesaid, in consideration of the sum of ten dollars and other valuable considerations, to me in hand paid at and before the sealing of these presents by Marshall Q. Turner, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Marshall Q. Turner, all that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, on Lenore Avenue between Arnshaw Avenue and Callahan Avenue, in Sans Souci Heights, a sub-division situate on the New uncorbed and about four miles north of the City of Greenville, said lot having the following lines, courses and distances:-

Beginning at an iron pin, on the northern edge of a three (3) foot sidewalk running along Lenore Avenue, said pin being the joint front corner of lots numbered one hundred and twenty (120) and one hundred and twenty-one (121); thence along the northern edge of said sidewalk, S. 67-11 E., seventy (70) feet, to an iron pin, joint front corner of lots one hundred twenty-one (121) and one hundred twenty-two (122); thence along the eastern line of lot one hundred and twenty-two (122), S. 35-19 E., one hundred and twenty-five and nine tenths (125.9) feet, to an iron pin, joint rear corner of lots one hundred and twenty-one (121) and one hundred and twenty-two (122); thence along the rear line of lot one hundred and twenty (120), N. 63-38 E., seventy (70) feet, to an iron pin, joint rear corner of lots one hundred and twenty-one (121) and one hundred and twenty (120); thence along the western line of lot one hundred and twenty (120), S. 34-59 E., one hundred and thirty (130) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbered one hundred and twenty-one (121) on plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "A" at page 95, which plat is hereby referred to and made a part hereof.

This property is sold subject to the restrictive covenants applicable to Sans Souci Heights, recommended by the Federal Housing Administration, and recorded by the owner in the U. S. Office for Greenville County in Book 425 at page 500, and the same is hereby referred to and made a part hereof.
