released, and by these presents does grant, bargain, sell and release unto E. B. Willis, Jr.,
his heirs and assigns:

All that certain piece, parcel or lot of land, lying and being at the ortheasterly corner of the intersection of 'edgewood Drive and Meadow Crest Circle, near the City of Greenville, South Carolina, being shown as Lot Mo. 23 on the plat of North Meadow Meights as recorded in the REC Office for Greenville County, S. C., in Flat Book "M", page 183, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of ledgewood Trive at the Northeasterly corner of the intersection of ledgewood Drive and Newdow Irost Circle and running thence along the Northwesterly side of edgewood Drive ... 62-14 101.5 feet to an iron pin, joint from corner of Lots Nos. 22 and 23; thence along the joint line of Lots Nos. 22 and 23 127-46 1140 feet to an iron pin on the line of Lot No. 24; thence along the joint line of Lots Nos. 23 and 24 562-14 1120.6 feet to an iron pin on the Northeasterly side of Neadow Crest Circle; thence along the Northeasterly side of Neadow Crest Circle S 28-30 E 115 feet to an iron pin at the intersection of leadow Crest Circle and Nedgewood Drive; thence around said intersection on a curve, the Chord of which is S 73-00 E, 35.6 feet to the point of beginning.

This is part of the property conveyed to the Grantor herein as shown by the deed recorded in Deed Book 419, page 347. This lot is conveyed subject to the building restrictions recorded in Deed Book 439, page 409.

The recorded plat above referred to indicates that the Greenville City Limites line runs through Lot No. 23.
