

Salter, Jr. and Rachel L. Salter--

All that certain piece, parcel or lot of land, with the buildings and improvements thereon situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Southeasterly side of Brookside Circle, being known and designate: as Lot #112, map of University Park, property of William S. H. Piper, plat of which is recor ed in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "P", page 127, and having, according to the said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeasterly side of Prookside Circle, joint front corner Lots #112 and #113, which iron pin is 300 feet in a Westerly direction from an iron pin in the Southwestern intersection of Beverly Lare and Brookside Circle, and running thence S. 3 -34 F. 182.3 feet to an iron pin, joint corner Lots #112, #113, #101, and #102; thence S. 52-26 !. 75 fret to an iron pin, joint corner Lots#111, #112, #102, and #103; thenc N. 37-34 W. 182.5 feet to an iron pin on the Southeasterly side of Brookside Circle; thence along the So theasterly side of Prooksije Circle N. 52-26 E. 75 feet to an iron pin, the point of Leginning.
