That I, E. L. Wilson in consideration of the sum of thirty-six hundred and no/100 in the State aforesaid, DOLLARS.

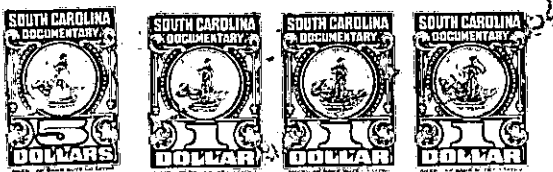

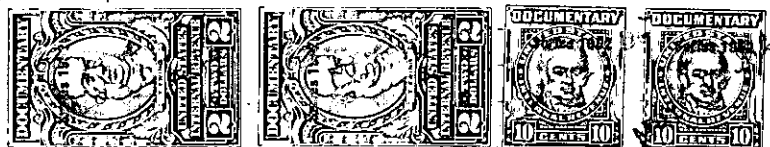
