Know All Men by These Presents:

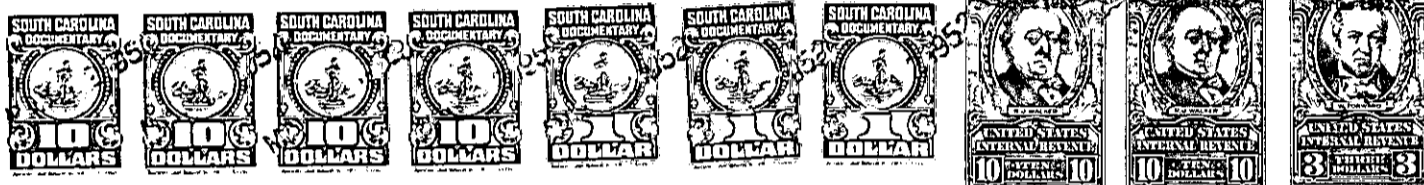

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. D. Taylor and Bertha Y. Taylor,

All that piece, parcel or lot of land situate, lying and being in the city of Greenville, county of Greenville, state of South Carolina, on the north side of Woods Crossing Road (sometimes called Airport Road), just off the Laurens Road, and having according to a survey and plat prepared by Dalton & Neves, Engineers, in May 1947 the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Woods Crossing Road (sometimes called Airport Road); thence S. 80-06 W. 168.8 feet to an iron pin; thence N. 23-19 W. 136.8 feet to an iron pin; thence N. 10-26 W. 76.4 feet to an iron pin; thence N. 80-06 E. 188 feet to an iron pin; thence S. 13-31 E. 210 feet to the point of beginning.

Being the same property conveyed to grantor by the Peoples National Bank of Greenville, S. C. as trustee under trust agreement dated July 10, 1951 by deed dated August 31, 1951 recorded in volume 441 page 155 of the R. M. C. Office for Greenville County.
