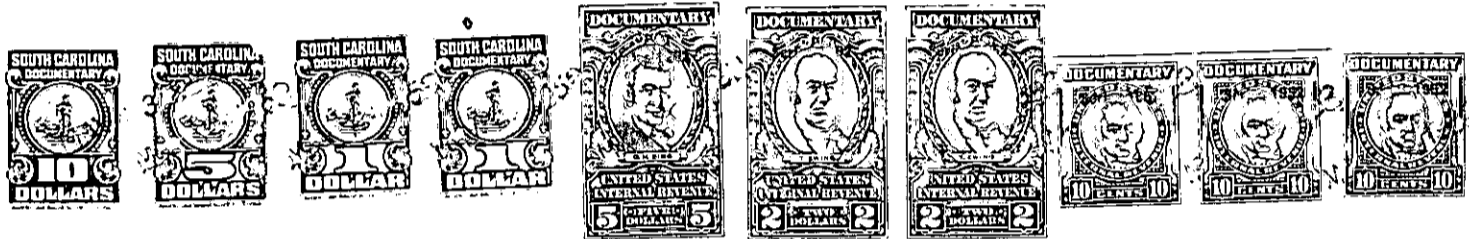
That Loys A. Jordan in the State aforesaid, in consideration of the sum of Eight Thousand Five Hundred and No/100 - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mary P. Hudson, her heirs and assigns forever:

All that certain piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, situate, lying and being on the North-western side of Sevier Street, and being partially shown as all of Lot No. 4 on plat of property of Willie H. Martin, et al, prepared by R. E. Dalton, Engr. in May, 1924, recorded in Plat Book "G" at page 246, R.M.C. Office, Greenville County, S. C., having according to a recent survey and plat of the property of Loys A. Jordan, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Sevier Street at the joint corner of Lots 3 and 4 and which point is 416.6 feet Southwest from the Southern edge of the Augusta Road; thence along joint line of said lots N. 57-20 W. 176.2 feet to an iron pin; thence S. 21-23 W. 61.17 feet to an iron pin; thence along the joint line of lots 4 and 5 S. 57-20 E. 188.2 feet to an iron pin on the Southwestern side of Sevier Street; thence N32-40 E. 60 feet to point of beginning.

Being the identical property conveyed to the Grantor by deed of Edwin McT. Meares dated January 28, 1941, recorded in Deed Book 230, page 86, said R.M.C. Office.
