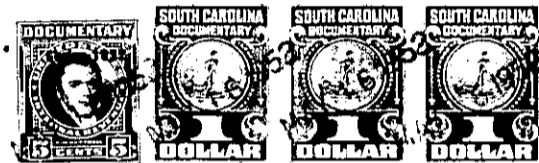

Boyd, his heirs and assigns forever.

All that certain piece, parcel or lot of land situate, lying and being on the northeast side of S. C. Highway No. 291, near the City of Greenville, S. C., in Butler Township, in Greenville County, State of South Carolina, being known and designated as Lot No. 1 according to a plat of the property of Pearl D. Mathews, made by Dalton & Neves, Engineers, September 1949 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING on an iron pin 372 feet south of the southeast corner of the intersection of the White Oak Church Road with S. C. Highway No. 291, said iron pin being on the northeast line of the right of way of said highway, joint front corner with the land now or formerly owned by E. E. Snipes and running thence N. 4-24 E. 198.9 feet along the line of said last mentioned property to an iron pin, joint rear corner of Lots Nos. 1 and 2; thence S. 49-08 W. 141.2 feet along the southeast line of Lot No. 2 to an iron pin on the northeast side of the right of way of S. C. Highway No. 291; thence S. 4-51 E. 140 feet along the northeast line of said highway to the point of beginning.
