All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot eighteen (18) on plat of Carver Park made by Piedmont Engineering Service, October, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book "AA", page 187, and having according to said plat the following courses and distances, to wit:

BEGINNING at a point on Tuskegee Avenue, joint corner of lots 18 and 19, and running thence along Tuskegee Avenue N. 87-12 W. 60 feet to corner of lot 17; thence along the line of lot No. 17 N. 2-48 E. 120 feet to corner of property of Caine Realty & Mortgage Company; thence along Caine Realty & Mortgage Company property S. 87-12 E. 60 feet to corner of lot No. 19; thence along the line of lot No. 19 S. 2-48 W. 120 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions recorded in the R.M.C. Office for Greenville County in Deed Book 444, page 498, which are made a part hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, which is recorded in said R.M.C. The lot herein conveyed constitutes a portion of the property conveyed to me by R. M. Caine, by deed dated March 10, 1951, and recorded in the R.M.C. Office for Greenville County in Deed Book 430, page 372.
