Know All Men by These Presents:

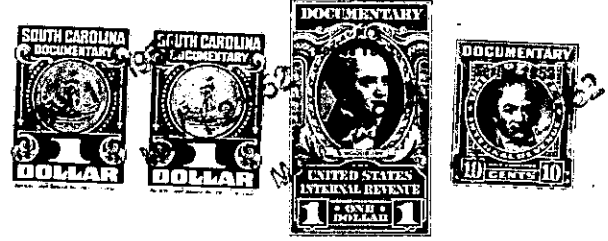

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Walter Wright, his heirs and assigns,

All that piece, parcel or lot of land in Greenville County, State of South Carolina, in City of Greenville, shown and designated as Lots Numbers Twenty Six and Twenty Seven (Nos. 26 and 27) in Block "B" on western side of Third Avenue on a plat of "Jefferson Heights" subdivision, made by W. D. Heves, Engr., Oct., 1912, recorded in Plat Book "C" at pages 34-35 in R. M. C. office, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at a point on western side of Third Avenue, joint front corner with Lot No. 28, and running thence S. 81-40 W. 87.5 feet along northern line of Lot No. 28 to point, joint rear corner of Lots Nos. 27, 28, 2 and 3; thence N. 0-30 E. 51 feet along rear line of Lots Nos. 2 and 1 to point on southern side of Nickle Street; thence N. 81-40 E. 87.5 feet along southern side of Nickle Street, to point at its intersection with Third Avenue; thence S. 0-30 W. 51 feet along western side of Third Avenue to the point of beginning.
