in consideration of the sum of Sixty-Five Hundred and No/100 (\$6500.00)--- DOLLARS,

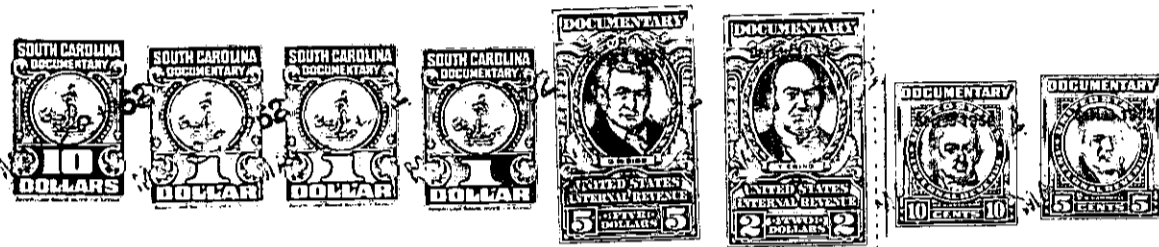
