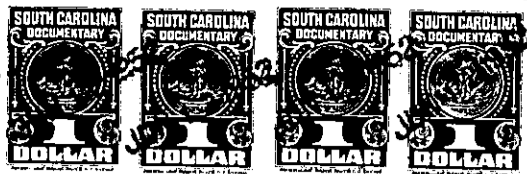

Know All Men by These Presents:

That We, William S. H. Piper by his attorney in Fact, Ruth M. Piper, and Ruth M. Piper in the State aforesaid, in consideration of the sum of Two Thousand (\$2,000.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(x) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Loys A. Jordan, his heirs and assigns,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 8, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Super Highway, U. S. #29, at the joint front corner of Lots Nos. 8 and 9 and running thence to joint line of said lots N. 37-34 W. 180 feet to an iron pin on the southern side of the 20 foot alley; thence with said alley N. 52-26 E. 100 feet to an iron pin, joint rear corner of Lots Nos. 7 and 8; thence with the joint line of said lots S. 37-34 E. 180 feet to an iron pin on the northern side of said Super Highway; thence along said highway S. 52-26 W. 100 feet to the point of beginning.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.

For Power of Attorney from William S. H. Piper to Ruth M. Piper, reference is made to Volume 349 at page 365.

This conveyance is subject to the Restrictive covenants recorded in Volume 325 at page 11 and amended in Volume 343 at pages 7 and 256.

Grantee to pay 1952 taxes.

It is the intention of the grantors that this conveyance shall extend to U. S. Highway No. 29 with the result that the lot conveyed herein shall abut on said highway.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(x) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(x) hereinabove named, and the grantee's(x) Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
