All my right title and interest the same being an undivided one-half interest in and to
All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina on the western side of Taber Street and being known and designated as Lot No. 21 and the northern five foot strip of Lot No. 22, according to a plat of Stone Estates made by G. M. Furman, Jr., dated December, 1931, and recorded in the R.M.C. Office for Greenville County in Plat Book G, at Page 294, and having the following metes and bounds, to-wit:

BEGINNING at a point on the western side of Taber Street, joint front corner of Lots Nos. 20 and 21, which point is 448.8 feet south of the intersection of Reid and Taber Streets and running thence along the line of Lot No. 20, 126 feet, more or less, to a point joint rear corner of Lots Nos. 20 and 21; thence S. 23-20 E. 30 feet to a point in the line of Lot 22; thence with the new line parallel to the dividing line between Lots Nos. 20 and 21, 126 feet, more or less, in a northeasterly direction to a point on the western side of Taber Street; thence along the western side of Taber Street, N. 23-20 E. 5 feet to the joint front corner of Lots Nos. 21 and 22; thence continuing along said Street, N. 23-20 E. 25 feet to the point of beginning
