. BEGINNING at an iron pin in the Northeast side of Corinne Drive, joint corner of lots 74 and 77, and running thence with joint line of said lots, N. 56-37 E. 207.5 feet to an iron pin, rear corner of lot 76; thence with rear line of said lot, N. 31-15 W. 100 feet to an iron pin, joint rear corner of lots 77 and 78; thence with joint line of said lots, S. 56-37 W. 205.8 feet to an iron pin in the Northeast side of Corinne Drive; thence with said Drive, S. 31-13 E. 101.9 feet to the point of beginning.

This property is conveyed subject to the following restrictions:

4. Any construction on this lot shall be set back a total of 50 feet from the front lot line.
