

Chloe Johnson Stanton, herein called grantee, all that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, known and designated as Lot 51 of a subdivision known as Isaqueena Park, a plat of which is of record in the R.M.C. Office for Greenville County in Plat Book P, at Pages 130 and 131, and having the following metes and bounds to-wit:

BEGINNING at a point on the south side of Harrington Avenue, the joint front corner of Lots 50 and 51, and running thence N. 50-35 W. 70' to an I.P.; thence S. 39-25 J. 200.4' to an I.P. at Spartanburg Street; thence along the line of Spartanburg Street S. 65-59 E. 73' to an I.P.; thence N. 39-25 E. 185.6' to the point of beginning.

This being the same property conveyed to me by B. L. Ayers, July 12, 1951, by deed recorded in Book 438 at Page 106. This lot is also shown on County Tax Map 189, Block 2, as Lot 66.
