CHURCH OF GOD TO TRUSTEES OF REAL ESTATE

THE CHURCH OF GOD

M. A. TOMLINSON, GENERAL OVERSEER

WHEREAS: Apparently certain persons have failed to distinguish between the CHURCH OF GOD which has headquarters on Montgomery Avenue, Cleveland, Tennessee, and an entirely separate church, the CHURCH OF GOD, OVER WHICH M. A. TOMLINSON IS GENERAL OVERSEER, which has its headquarters at Bible Place, Cleveland, Tennessee, which latter church is now known in all its business affairs as THE CHURCH OF GOD OF PROPHECY, and

WHEREAS: A resolution of the Annual Assembly of the Church of God, M. A. Tomlinson, General Overseer, Headquarters Office, Bible Place, Cleveland, Tennessee U. S. A., has been duly

recorded in Clerk of Court's Office, Murfreesboro, Tenn., in
Book 218, page 361 which resolution reads substantially as follows:

"We, your questions and subjects committee, after prayer and careful consideration deem it of great necessity to bring before this Assembly the following recommendations:

1. Because of the fact that the Church holds a considerable amount of property in foreign mission fields, much of it bought with Church funds, and also has other Church properties, we believe it to be very important that this Assembly select five (5) trustees to act as general trustees and custodians of the Church real estate and to be responsible for its care and protection, they to be authorized and empowered to protect and care for and hold such property generally and to succeed to and have all authority now vested in other trustees or custodians holding Church real estate of the Church of God over which A. J. Tomlinson was General Overseer, and M. A. Tomlinson his successor in office, Headquarters Office, Bible Place, Cleveland, Tennessee, U. S. A.

2. We recommend further that all vacancies which may occur in this board of trustees be filled by appointment of the General Overseer. Said board to be composed of the following: The General Overseer, the General Treasurer, Business Manager of the White Wing Publishing House, General Foreign Missionary Secretary, and General Field Secretary No. 1."

WHEREAS: The General Trustees, named pursuant to said resolution and later resolutions of the General Assembly, at present consist of the following named persons: M. A. Tomlinson, J. R. Kinser, C. T. Davidson, Robert F. Wright, and C. R. Payne; and _____

WHEREAS: The said Church and General Trustees have been ordered by the Chancery Court at Cleveland, Tennessee to cease and desist from maintaining any instrument of record in the Land Records Office of any County in the United States which might cast, or be a cloud upon the title of real property owned or held by the CHURCH OF GOD.

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES, the said General Trustees hereby declare that the Church which was formerly known as the Church of God over which A. J. Tomlinson is General Overseer, and which was later known as the Church of God over which M. A. Tomlinson is General Overseer, is now, pursuant to decree of said Chancery Court, known as THE CHURCH OF GOD OF PROPHECY and is transferring all its real property to Trustees who will hold said real property for the use and benefit of THE CHURCH OF GOD OF PROPHECY with Headquarters at Bible Place, Cleveland, Tennessee.

That the said resolution, hereinabove referred to, does not encumber, and places no restrictions upon the title to any real property owned or held by the CHURCH OF GOD, or Trustees for use and benefit of same, but only applies to such property of THE CHURCH OF GOD OF PROPHECY.
