All that certain piece, parcel or tract of land in Chick Springs Township, Greenville County, South Carolina, containing 21.77 acres, more or less, and being all of the 24.67-acre tract of land as shown on Plat of W. R. Boling Estate, made by T. T. Dill April 29, 1952, except 2.90 acres taken from the northern portion of said tract, and having according to the above referred to plat the following metes and bounds, to-wit:
