Know All Men by These Presents:

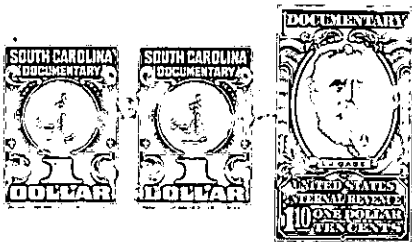
That I, Mona H. Squires in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Sarah L. Wallace, her heirs and assigns forever

All that lot of land in Greenville Township, Greenville County, South Carolina, known and designated as Lot No. 27 on plat of property of Mona Harris Squires made by Richmond Machine and Service, February 1948, and having the following lot and bounds:

Begin on the west side of Florida Avenue at the corner of Lot 26; thence with the west side of Florida Avenue N. 22-10 W. 65.5 feet to the intersection of Peachtree Street and Florida Avenue; thence with the South side of Peachtree Street S. 71 W. 200 feet to a pin on the South side of Peachtree Street corner of Lot 10; thence S. 22-10 W. 65.5 feet to the common corner of Lots 10, 11 and 26; thence with Lot 26 N. 71 E. 200 feet to the beginning corner on West side of Florida Avenue.

This conveyance is subject to restriction that the said property shall not be leased or conveyed to any person of African descent since it is located in an entirely white neighborhood.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
