KNOW ALL MEN BY THESE PRESENTS, That Caesars Head Company, Incorporated

..... a corporation, in consideration of the sum of \$ 1.00 to it in hand paid by DUKE POWER COMPANY,

the receipt whereof is hereby acknowledged, does hereby grant unto said DUKE POWER COMPANY, its successors and assigns, the right, privilege, and easement to go in and upon that certain tract or lot of land

situated in said County and State, ~~bounded by lines of~~ being the area of Caesars Head Company, Incorporated, Development known as the Oil Camp Drive Section, situated in Cleveland Township, Caesars Head, S. C.;

and to construct, maintain and operate in, upon and through said premises, in a proper manner, with poles, wires and other necessary apparatus and appliances, a line for transmitting power by electricity, and for telephone purposes, together with the right at all times to enter said premises for the purpose of inspecting said line and making necessary repairs and alterations thereon, together with right at all times to cut away and keep clear of said line all trees and other obstructions that may, in any way, endanger the proper maintenance and operation of the same; also including the right to relocate said line over said premises to conform to any future highway relocation, widening or improvement. Proposed power line to run from the transformer pole now serving the Hodges cottage in a westerly direction to a point on the opposite (Southern) side of U S Hwy No. 276 and the western side of Oil Camp Drive; thence approximately 135' to an old pole location eastern side of Oil Camp Drive; thence approximately 135' to a pole located on the property of Campbell and Pierson.
