The above described property was conveyed to Eston L. Rodgers by deed of Bessie Jones Martin, dated December 11, 1950, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 425, at page 55.

Subsequently, the above described property was surveyed and subdivided into lots and is now shown as Colonial Estates on a plat made by Dalton & Neves, Engineers, April 1951, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "W", at page 173.

Eston L. Rodgers conveyed Lot 3 on plat of the said Colonial Estates to Harry R. Kennedy and Elizabeth B. Kennedy by deed recorded in said R. M. C. Office for Greenville County, S. C., in Deed Book 434, page 101 Therefore, Lot 3 on said plat is EXCLUDED from this conveyance.

The said Eston L. Rodgers subsequently conveyed Lots 1 and 2 on plat of Colonial Estates to the Grantor, Juanita F. Rodgers, by deed recorded in said R. M. C. Office for Greenville County, S. C., in Deed Book 450, at page 265. Thereafter, Juanita F. Rodgers sold and conveyed Lot 2, which lot is EXPRESSLY EXCLUDED from this conveyance, but the said Juanita F. Rodgers has joined in this conveyance as one of the Grantors for the purpose of conveying to the Grantees Lot 1 on plat of Colonial Estates.

The streets and roads shown on the plat of Colonial Estates have been previously conveyed to the County of Greenville, and that area lying within said streets shown on plat of Colonial Estates are EXCLUDED from this conveyance. (over)
