to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Furman C. Smith and J. Hoyt Sentell, their heirs and assigns, forever.

All that piece, parcel or lot of land on the west side of Mayfair Lane, in the City of Greenville, Greenville County, South Carolina, shown as Lot 11, on plat of Holmes Acres, made by Dalton & Neves, Engineers, February 1951, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "2", at Page 1, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Mayfair Lane, at joint front corner of Lots 11 and 12 and running thence with the line of Lot 12, S. 88-07 W. 149.5 feet to an iron pin; thence S. 3-07 E. 94 feet to an iron pin on the north side of Holly Street; thence with the north side of Holly Street, S. 83-26 E. 113 feet to an iron pin; thence continuing with the curve of Holly Street (the chord being N. 47-20 E. 39.3 feet) to an iron pin on the west side of Mayfair Lane; thence with the west side of Mayfair Lane, N. 1-53 W. 86.3 feet to the beginning corner.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

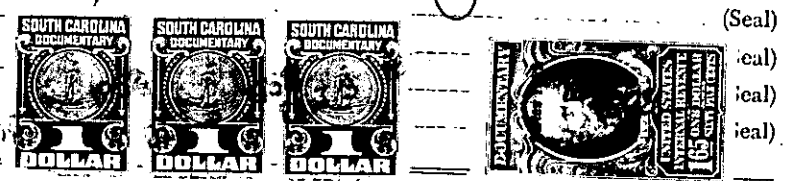
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.
