to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Dorothy S. Wilson and Manning M. Wilson, their heirs and assigns forever:

ALL that piece, parcel or lot of land about three miles from Greenville Courthouse, being known and designated as Lot No. 103 of Sunset Hills, according to a plat thereof, made by R. E. Dalton, dated December, 1945, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P, at Page 19, and according to said plat, having the following metes and bounds, to wit:

BEGINNING at an iron pin joint corner of Lots No. 103 and 104 and running thence along the line of said Lot No. 104, S. 48-50 W. 193.4 feet to iron pin; thence S. 32-23 E. 77 feet to iron pin; thence N. 55-30 E. 206.4 feet to iron pin on Waccamaw Circle; thence running with the said Waccamaw Circle N. 41-10 W. 99.5 feet to beginning corner.

SAID property is subject to the restrictions or protective covenants contained in the instrument executed by Noland Meyers, dated March 6, 1946, recorded in the R. M. C. Office for Greenville County, South Carolina, Book of Deeds 288, at Page 204, as fully and completely as though said restrictions or protective covenants were fully and completely set forth in this deed.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
