All of our undivided right, title and interest in and to that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina located on the Northern side of the Reedy Fork Road about one-half mile from the Reedy Fork Baptist Church, as shown on plat made and revised by W.
