That I, Joe H. Long in consideration of the sum of Nine Hundred Fifty and no/100 (\$950.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. V. McClain, his heirs and assigns:

All that certain piece, parcel or lot of land lying and being on the Southeasterly side of Carolina Avenue, in the City of Greenville, S. C., being shown as Lot No. 11, Block "J", Section 5, on the Plat of East Highlands Estates as recorded in the RMC Office for Greenville County, S. C. in Plat Book "K", pages 78-80, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeasterly side of Carolina Avenue, said pin being the joint front corner of Lots Nos. 11 and 12, Block "J", Section 5, and running thence along the joint line of said Lots S 45-58 E 168.6 feet to an iron pin; thence N 87-50 E 127 feet to an iron pin on the Westerly side of a 5 foot strip reserved for utilities; thence along the Western edge of said 5 foot strip N 0-24 W 50.5 feet to an iron pin in the center of a 3 foot strip reserved for a drain, said pin being also the joint rear corner of Lots Nos. 10 and 11; thence along the center of said 3 foot strip, said center line being the joint line of Lots Nos. 10 and 11, N 63-50 W 238.3 feet to an iron pin on the Southeasterly side of Carolina Avenue; thence along the Southeasterly side of Carolina Avenue on a curve, the chord of which is S 38-04 W 55 feet to the point of beginning.
