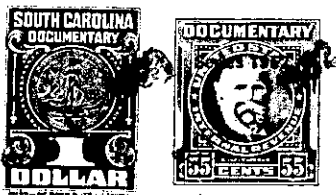

all that piece, parcel or lot of land in Paris Mountain Township, Greenville  
County, State of South Carolina, and described as follows:

ALL THAT certain piece, parcel or tract of land  
in Paris Mountain Township, County of Greenville, State of South Car-  
olina, having the following metes and bounds:

BEGINNING at a iron pin in Settlement Road on  
line of William Priestly property thence along said line N. 4-0 W.  
201.5 Feet to a stone; thence along the line of same property N. 85-40 W.
