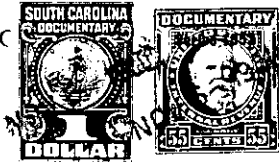

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Robt. J. T. Styles and Ruth G. Styles, their heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, approximately three miles north of Travelers Rest, South Carolina, on the western side of U.S. Highway No. 276 (Travelers Rest-Caesar's Head Road), being known and designated as Lot No. 50 on the plat of property of the Nannie K. Hunt Estate made by H. L. Dunahoo, Surveyor, dated November, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book AA, at Page 134, and having according to the said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Gilreath Street, joint front corner of Lots Nos. 50 and 51 and running thence along the line of Lot No. 51, S. 63-30 W. 200 feet to an iron pin in the line of Lot No. 62; thence along the line of Lot No. 62, N. 26-15 W. 100 feet to an iron pin, corner of Lot No. 49; thence along the line of Lot No. 49, N. 63-30 E. 200 feet to an iron pin on the western side of Gilreath Street; thence along the western side of said street, S. 26-15 E. 100 feet to the point of beginning. Being a portion of the same property conveyed to me by S. T. Turner, et al, of record in the R.M.C. Office for Greenville County in Deed Book 461, at page 301.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named; and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
