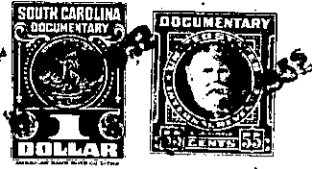

Know All Men by These Presents.

That I, M. W. Fore in consideration of the sum of Three Hundred Seventy-five & 00/100-----(\$375.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joseph H. Brannon and Pauline Brannon, their heirs and assigns, forever:

ALL that piece, parcel or lot of land near the City of Greenville, State of South Carolina, being known and designated as Lot No. 69 of a subdivision known as Bellwood Estates, as shown by a plat thereof, dated May, 1950, and made by Dalton & Neves, Engineers, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin joint corner of Lots No. 69 and 70 and running thence along the line of said Lot No. 70, N. 10-44 E. 170.4 feet to iron pin in line of Lot No. 62; thence along the rear of Lots No. 62 and 63, S. 73-20 E. 105. feet to iron pin at joint back corners of Lots No. 69, 63, 66 and 67; thence running with the rear line of Lots No. 67 and 68, S. 21-06 W. 162.5 feet to iron pin on Silver Lake Drive; thence with the said Silver Lake Drive N. 78-53 W. 75 feet to iron pin, point of beginning.

NO residence costing less than Five Thousand (\$5,000.00) Dollars shall be erected on lots fronting on Old Rutherford Road or Oxford Boulevard; no residence costing less than Thirty-five (\$3,500.00) Dollars shall be erected on any other lot in Bellwood Estates; no residence shall be erected on any lot nearer than twenty-five (25) feet to the front line; no outside toilets permitted. This property sold subject to rights-of-way to Duke Power Company, granted or to be granted, for residence power lines.

GRANTEE to pay taxes for the year 1952.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
