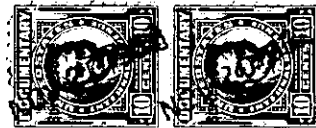

Know All Men by These Presents:

That I, E. R. Griffin, in the State aforesaid, in consideration of the sum of Eleven Thousand Nine Hundred Fifty and No/100 - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. M. Sightler, his heirs and assigns, forever:

All that lot of land with the buildings and improvements thereon, situate on the Northwest side of Perrin Street, in the City of Greenville, Greenville County, South Carolina, being shown as Lot 6 on plat of Property of E. R. Griffin, made by Dalton & Neves, Engineers, August 1951, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "AA", at page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Perrin Street at joint front corner of Lots 6 and 7, and running thence with the line of Lot 7, N. 30-39 W. 182.7 feet to an iron pin; thence N. 61-44 E. 62 feet to an iron pin; thence with the line of Lot 5, S. 31-57 E. 188.9 feet to an iron pin on the Northwest side of Perrin Street; thence with the Northwest side of Perrin Street S. 66-57 W. 66.8 feet to the beginning corner.

This is a portion of the property conveyed to the Grantor herein by deed of C. F. Pittman, Sr., dated June 15, 1951 and recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 436, at page 379.
