to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. D. Hood and Grace Hood, their heirs and assigns, forever:

*ALL that piece, parcel or lot of land near the City of Greenville, Greenville County, State of South Carolina, being known and designated as Lot No. 12 of a subdivision known as Marion Grove as shown by a plat thereof, dated October, 1952, made by Dalton & Neves, Engineers, recorded in the R. M. C. Office for Greenville County in Plat Book "BB", at Page 137.

BEGINNING at an iron pin on Marion Street at joint front corners of Lots No. 12 and 13 and running thence along the line of said Lot No. 13, S. 18-45 E. 160 feet to iron pin; thence N. 71-15 E. 100 feet to iron pin at rear corner of Lot No. 11; thence along the line of said Lot No. 11, N. 18-45 W. 160 feet to iron pin on Marion Street; thence running with the said Marion Street S. 71-15 W. 100 feet to iron pin at point of beginning.

THIS property is subject to the following restrictions:

That the said lands shall not be sold, rented or otherwise disposed of to any negro or person of African descent; no residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on any lot; no residence shall be erected on any lot nearer than thirty-five (35) feet to the front line; no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage; no outside toilets permitted, and sewage is to be disposed of by approved septic tanks.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
