to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James Moore and Zora M. Moore, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 33 of a subdivision known as Section "A", of Englewood Estates, as shown by a Plat thereof, dated October, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "Y", at Page 140.

BEGINNING at an iron pin on Burbank Drive at the joint front corners of Lots No. 32 and 33 and running thence along the line of said Lot No. 32, N. 87-30 W. 150 feet to iron pin; thence S. 2-30 W. 75 feet to iron pin; thence along the rear line of Lots No. 35 and 34, S. 87-30 E. 150 feet to iron pin on Burbank Drive; thence running with the said Burbank Drive, N. 2-30 E. 75 feet to iron pin at point of beginning.
