to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

B. B. Corvette and Stella R. Corvette, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lots No. 87 and 89 of a subdivision known as Section "A", of Englewood Estates, as shown by a Plat thereof, dated October, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "Y", at Page 140.

BEGINNING at an iron pin on Woodbine Drive at joint front corners of Lots No. 85 and 87 and running thence along the line of said Lot No. 85, N. 2-30 E. 200 feet to iron pin; thence along the rear lines of Lots No. 86 and 88, N. 87-30 W. 200 feet to iron pin at back corner of Lot No. 91; thence along the line of said Lot No. 91, S. 2-30 W. 200 feet to iron pin on Woodbine Drive; thence with the said Woodbine Drive, S. 87-30 E. 200 feet to point of beginning.
