Know All Men by These Presents:

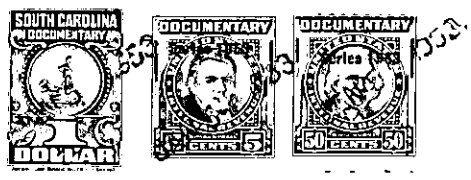
That I, J. Frank Williams, in the State aforesaid, in consideration of the sum of Three Hundred Fifty and No/100- - - DOLLARS,

Lucy Wood, her Heirs and Assigns:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being known and designated as Lot No. 2 of Poplar Valley, plat of which is recorded in the R.M.C. office in Plat Book "V", Page 97, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of a County road, joint front corner of Lots Nos. 1 and 2, and running thence with the line of said lots N. 89-45 E., 160.6 feet; thence N. 32 E., 127.8 feet to joint rear corner of Lots Nos. 2 and 3; thence with the line of said lots S. 87-50 W., 216 feet to the joint front corner of lots Nos. 2 and 3 on said County road; thence with said County Road S. 7-30 W., 100 feet to the point of beginning.
