to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Greenville Home Builders, Inc., its successors and assigns, forever:

All that lot of land situate on the west side of McDaniel Avenue, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 25, on Map # 2 of Cleveland Terrace, made by Dalton & Neves, Engineers, May, 1931, revised August 1941, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book K, at pages 98 and 99, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of McDaniel Avenue at joint front corner of Lots 24 and 25 and running thence with the line of Lot 24, N. 75-55 W. 200 feet to an iron pin; thence S. 12-43 E. 70 feet to an iron pin; thence with the line of Lot 26 S. 75-55 E. 200 feet to an iron pin on the West side of McDaniel Avenue; thence with the west side of McDaniel Avenue, N. 12-43 E. 70 feet to the beginning corner.

This property is conveyed subject to the following restrictions:

- (1) This property shall be used for residential purposes only.
- (2) No dwelling shall be built on said lot costing less than \$7500.00
- (3) No building shall be erected nearer than 35 feet to McDaniel Avenue.
- (4) No residence shall be built on said lot facing in any direction other than McDaniel Avenue.

This is a portion of the property that was owned by W. C. Cleveland at the time of his death on August 26, 1946, and this conveyance is made by the Grantors, as Executors under the will of W. C. Cleveland pursuant to the power and authority conferred on us by his will dated January 17, 1940 on file in the Probate Court for Greenville County, S. C. in Apartment 518, File 29.
