ALL that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about three miles southwest from Greer, S. C., being bounded on the north by lands of Roscoe Green Estate, on the east by other lands of myself, on the south by lot of F. S. Nix and on the west by lands now or formerly of Mrs. Greer, and being a part of the same land that was conveyed to me by deed from Victoria Elmore et al. January 16th 1913, recorded in the office of the R. M. C. for said county and state in Deed Book 24 at page 20, and having the following courses and distances, to wit:-

Beginning on an iron pin on the Green Estate line, joint corner of the Greer tract, and runs thence S. 21-05 E. 580 feet to an iron pin, joint corner of the F. S. Nix land; thence with the Nix line, M. 69-15 E. 607 feet to a stake or iron pin on or near the old bed of Princess Creek; thence up the general direction of the olf creek bed, N. 9-25 W. 673 feet, more or less, to an iron pin on the Thomas L. Smith Estate line; thence with the Smith line, S. 69-45 W. 350 feet to an iron pin near a Wild Cherry tree; thence with the Roscoe Green Estate line, 3. 58-00 W. 412 feet to the beginning corner, containing Nine and Ninety Four Onehundredths (9.94) acres, more or less.
