All that piece, parcel or lot of land in Greenville Townshir, Greenville County, South Carolina, including the buildings and improvements thereon, situate, lying and being situate on the Southwest side of Northwood Avenue, being known and designated as Lot 20, according to revised plat of the Property of Furman C.
